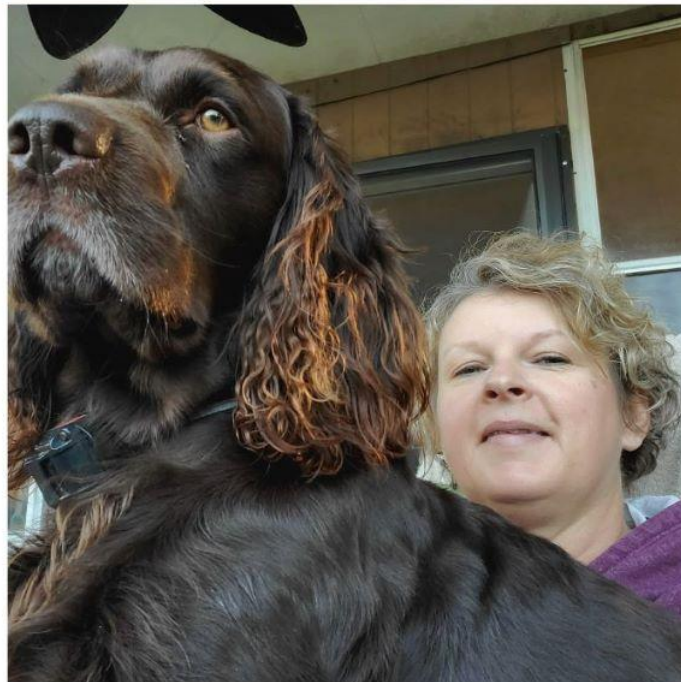

State Benefits

Alabama GI Dependent Scholarship (AGIDS)

- Effective July 31, 2017
- Must complete FAFSA each year
- Must maintain SAP
- Pell Grant pays first

Alabama National Guard Educational Assistance Program(ANGEAP)

- Must complete FAFSA each year
- Must maintain 2.0 GPA or 3.0 for graduate
- Pell Grant pays first

Federal Benefits

Students receiving VA Education Benefits under Chapter 33 (Post 911), Chapter 30 (MGIB), Chapter 1606 (SR), Chapter 35 (DEA) or Chapter 31 (VRE) can use Pell Grant and their benefit.

Chapter 30, 1606 and 35 can use their Financial Aid to pay for tuition and books.

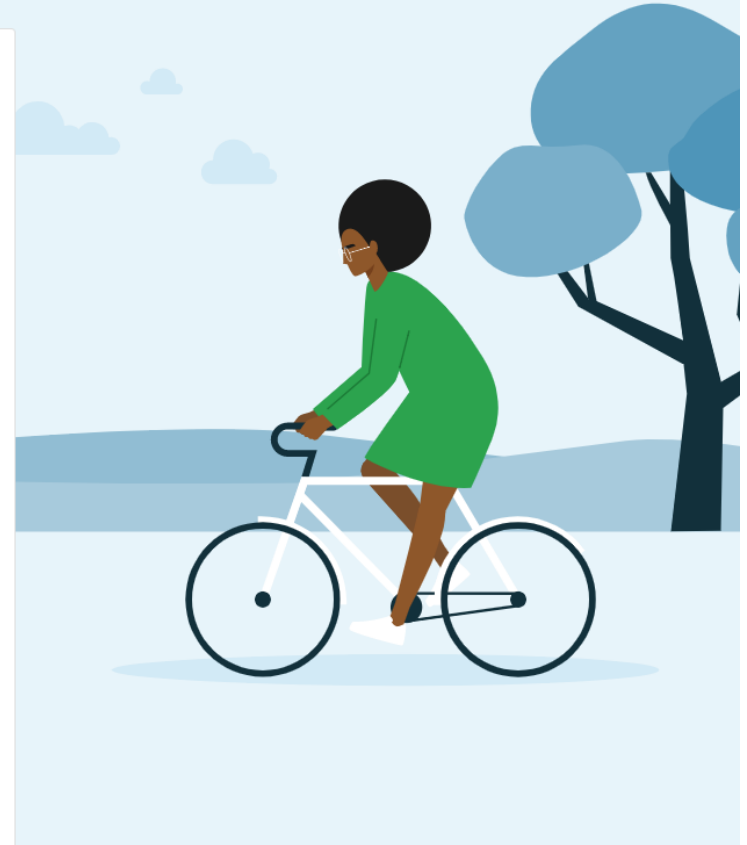

Definition of veteran

Department of Defense

The military veteran definition as outlined in the 38 U.S Code – 101 is a person who has served in the naval, air, or space military service and was released or discharged honorably.

Department of Education

- Active service
- Released under a condition other than “dishonorable”
- No minimum amount of time
- National Guard/Reserves only if called up to active federal duty by presidential order other than training.

Service Academies

- U.S. Military Academy (West Point)
- U.S. Naval Academy (Annapolis)
- U.S. Air Force Academy
- U.S. Coast Guard Academy
- U.S. Merchant Marine Academy
- U. S. Military Academy Preparatory School
- Naval Academy Preparatory School
- U.S. Air Force Academy Preparatory School

Verification

- CPS will perform a data match with VA records to confirm Veteran Status
- If VA confirms that the student is a veteran, nothing needs to be done.
- If VA database indicates he/she is not a veteran then the student needs to bring in a DD214, Member 4.
